DEFINITION

It used for adhering PVC rolls and tiles to the floor It is a strong, water-based, solvent-free, acrylicbased adhesive.

It is used in the assembly of PVC, polyurethane and latex-based floor coverings.

APPLICATION

The surface on which PVC, vinyl or other coating materials will be applied must be smooth, clean, dry and free of cracks. In case the surface is not smooth or there is deformation, the surface should be smoothed with floor leveling screed. GRADA PVA ULTRA is spread on the floor with an A2, A3 or B1 comb. PVC, vinyl or other covering material is installed 10-20 minutes after the material is spread on the floor. During the application, the ambient temperature should not be below + 5°C. Hot welding should be done after 24 hours. At the end of the work, cleaning can be done with warm water. Cleaning of the tools used is also done with warm water.

SHELF LIFE

1 year from the date of production, under suitable storage conditions (in a cool and dry environment at $+5^{\circ}C - +35^{\circ}C$).
